**STUDENTS MUST ATTEND 16 SESSIONS OF LECTURE AND 16 SESSIONS OF DRIVING**  
**Students must have a textbook, a pen and their permit each time they attend class.**

Dress Code: Casual; Shorts and shirts of reasonable length will be allowed. SHIRTS MUST HAVE SLEEVES. No Tube Tops, Tank Tops, Half Shirts, Halters, Bathing Suits, etc. No Studed jewelry or heavy chains. Hats and caps must be removed inside the building. NO SANDALS OR LOOSE FOOTWEAR ARE ALLOWED DURING DRIVING INSTRUCTION. Francis School reserves the right to refuse entrance to any student found to be wearing anything not to standard in their discretion.

Any student arriving late for class will not be admitted to lecture or picked up by the driving instructor and will receive an absence for that day. **DO NOT BANG ON OR KICK THE DOORS.** This behavior will result in dismissal from the program without a refund.

Absences must be made up. All make-up classes will be scheduled through the Drivers Education office. More than three consecutive absences will result in dismissal from the program without a refund. Students may not bring food, beverages or candy/gum in to the building or cars; write on blackboards, desks or any part of the school building; throw or drop paper or garbage on the floors; Cell phones and pagers **MUST** be turned off during instruction times; Students must follow the directions of their instructor at all times. No smoking is permitted anywhere in the school building or on any school property including outside the front of the building. No food is permitted either inside or outside of the school building or anywhere on school property. No students are allowed to be inside the building if they are not attending lecture in the designated room. **UPON SUCCESSFUL COMPLETION, STUDENTS WILL RECEIVE**

- MV-285 (Part B)** Eligibility for reduction of Insurance Premium (5 years);
- MV-262** Certification of 50 Hours of Supervised Driving;
- Road Test Appointment** with the use of the driver education car if you so choose (Additional charges may apply).
